Bids are to be submitted with an individual property price and combined price for the specified demolition and grade work on the properties listed on the bid schedule.

The City of Cherryvale reserves the right to accept or reject any or all bids, or to waive any informalities or minor defects should they occur, as may best benefit the City of Cherryvale.

A general release of Liability form will be provided in the bid packet. This form will need to be signed by all parties that will be working on city properties.

Proof of liability insurance and workers compensation insurance shall be furnished with the bid. Liability insurance shall require a minimum of \$500,000.00

The City of Cherryvale reserves the right to make any investigation deemed necessary by the City to determine the ability of the bidder to do the project. Bidders shall furnish to the City of Cherryvale such information as requested to determine the bidder's qualifications. The City of Cherryvale further reserves the right to reject any bid if the City deems the bidder to be improperly qualified to complete the project.

Bids shall be guaranteed for a period of sixty (60) days from the date and the set to receive bids.

INFORMATION FOR BIDDERS

Bids will be received by the City of Cherryvale at the office of the City Clerk until 12:00 PM, October 7th, 2024, at which time the bids will be opened at 3:00 p.m. publicly and read aloud. The bid will then be submitted to the Cherryvale City Council at a regular meeting for their formal action.

Each bid must be submitted in a sealed envelope addressed Karen Davis, City Clerk, City of Cherryvale, 123 W. Main St, Cherryvale, KS 67335, plainly marked on the outside "City Property Dozer Work Bid ". The envelope shall bear on the outside the name and address of the bidder. If forwarded by mail the sealed envelope containing the bid shall be sealed in another sealed envelope also plainly marked and addressed as above.

All bids must be submitted on the attached Bid Schedule. The Bid Schedule must be fully completed and executed with all blank spaces filled in with ink or typewritten. Only one (1) copy of the Bid Schedule is required and will be accepted.

Bids shall be guaranteed for a period of sixty (60) days from the date and time set for receiving bids. The City of Cherryvale reserves the right to accept or reject any or all bids or to waive any informalities or minor defects should they occur as may best to benefit the City of Cherryvale. Any bid may be withdrawn by the bidder up to the scheduled time set for the opening of the bids or authorized postponement thereof. Any bid received after the date and time set for the bid opening shall not be considered and shall be returned unopened to the bidder. No bidder may withdraw a Bid within sixty (60) days after the actual date and time set for the Bid opening. Should there be reasons why the contract cannot be awarded within the specified period; the time may be extended by mutual written agreement by and between the City of Cherryvale and the bidder.

Bidders must satisfy themselves of the conditions and requirements of the location in the Bid Form by a personal examination of the site and review of the specifications including any and all addenda. After the Bids have been submitted and received by the City of Cherryvale, the bidder may not assert that there was a misunderstanding concerning the quantities or the scope of the work to be done.

The City of Cherryvale shall provide to the bidders prior to the scheduled bid opening any information which, in the judgment of the City of Cherryvale, is pertinent to and delineates and describes the project.

The Contract Documents contain the provisions and requirements for the project. Information obtained from an officer, agent, employee of the City of Cherryvale or any other person shall not affect the risks and obligations assumed by the Contractor or relieve him from fulfilling any and all of the conditions of the contract.

The successful bidder to whom the Contract is awarded shall execute four (4) copies of the Contract Documents as provided by the City of Cherryvale, each of which shall be considered an original document. In case of failure by the Bidder to execute the Agreement within the time period set, consider the Bidder in default and award the contract to the next available and most responsible bidder.

Should the City of Cherryvale not execute the Documents within such time period, the Bidder may, by written notice, withdraw his signed Agreement. Such Notice of Withdrawal shall be effective

upon the date of receipt.

The Notice to Proceed shall be issued within ten (10) days of the execution of the agreement pending the approval of the appropriate Federal and State agencies. Should there be reasons why the Notice to Proceed cannot be issued other than pending Federal and State agency review, the time may be extended by mutual agreement by and between the City of Cherryvale and the Contractor. If the Notice to Proceed has not been issued within the ten (10) day period or within the extended period mutually agreed upon as stated above, the Contractor may terminate the Agreement without further liability on the part of the City of Cherryvale or the Contractor.

The Contractor shall notify the adjoining property owner(s) within forty-eight (48) hours before commencing any work on the project that will affect any residence or business establishment.

The City of Cherryvale may make any such investigations as it deems necessary to determine the ability of the bidder to perform the work and the bidder shall furnish to the City of Cherryvale all such information and data for this purpose as the City of Cherryvale may request. The City of Cherryvale reserves the right to reject any bid if the evidence submitted by and subsequent investigation of the bidder fails to satisfy the City of Cherryvale that such bidder is properly qualified to carry out the obligations of the Agreement and to complete in a workmanship manner the project as specified in the Plans and Specifications.

A conditional or qualified bid shall not be accepted.

The Contract shall be awarded to the most responsible bidder, and which is in the best interest of the City of Cherryvale.

All applicable laws, ordinances, rules, and regulations of all authoritative agencies having authority over any or all of the construction of the project shall apply to the Contract throughout.

Each bidder is responsible for inspecting the locations, reading and being thoroughly familiar with all of the Contract Documents. The failure or omission of any bidder to do any of the foregoing shall in no way relieve the successful bidder from any obligation in respect to his bid.

The approved bidder shall furnish to the City of Cherryvale the names and addresses of all subcontractors if requested to do so by the City of Cherryvale.

ONLY CROSS THE SEWER LINE IN AREA DESIGNATED BY CITY STAFF

TREE/BRUSH DUMP

Level out burn area.

Any large stumps will be piled up for burning. Any large rocks or concrete will be pushed out of the burn area and put in a pile. The chips pile will be pushed west to the berm and placed there.

169 HWY PROPERTY (5332 CR 5050)

Existing house will be knocked down and put in a pile for removal by the City. Existing septic system will need to be filled in after removing lateral lines. Any remaining concrete and slabs will be buried on site.
